**PUBLIC SPEAKS (CITY BUSINESS):** Alice Sarver from Neighborhood Leadership Council sharing city wide concerns with Council and the administration. There will be representatives from the Neighborhood Associations here at the October 4, 2010 Council Meeting and they would like to get some answers to the questions provided in the information packet given to all Members this evening. Minnie Evans says that things have gotten worse in her neighborhood after the return of Bobby Campbell. He was an issue in this area for many years and left but now he has returned. When the Police are called, they will not even respond because they know of his problems. She does not know who else to contact about these problems or how to deal with them and needs some assistance. Demetrius Truitt has designed a program for youth called "Straight from Scratch" and it is building a business from scratch. This is a mentorship for youth and teens in environmental beautification with hands on experience using tools, education, etc. and is free. He will be working with the Edward "Peel" Coleman Center on this project. Melissa Pearce is from the Domestic Violence Project that helps to keep Canton residents safe with shelters and emergency housing for victims of violence. 105 women and 107 children stayed in their shelter last year with the aid of the grant money approved by Council. There is a 24 hour hotline at the shelter. They also assist residents with education, legal aid and transportation to give hope for a future without violence and trying to help families emerge from crisis.

**MISCELLANEOUS BUSINESS:** Member Cirelli wants to know if Ohio Billing can be used for collection efforts on all city owed monies and utilities. Law Director Martuccio will be working on items for Ordinance #8 to get all of the language correct. He will also be reviewing the possibilities of Ohio Billing doing some additional collections for the city and how their fee structure is set up. This may be more costly than beneficial for the numbers of accounts that have smaller unpaid balances than the current method of assessing the taxes. Member West thanking the young man from "Straight from Scratch." He knows that he is very passionate about entrepreneurship and helping the youth. Member West also wanted to thank and congratulate Member Smith on a job well done in the Sherrick Road area and apologize for not being able to attend the function Sunday. Member Smith thanked all that attended the parade and festivities yesterday including Members Smuckler and Cirelli and thanked Member Dougherty for his support. She also wanted to thank the Mayor for dancing down the road with her. Safety Director Ream would like to invite all to the groundbreaking ceremony Wednesday, September 29<sup>th</sup> at 3:30 PM for the new Fire Station at 25<sup>th</sup> St NW and Cleveland Ave. This is the first step in carrying out a long range plan for public safety in Canton. President Schulman asked the Mayor to check on information pertaining to Southwest Airlines purchase of Airtran Airways. This may greatly effect the flights coming in and out of the Akron/Canton Airport which will also effect companies wanting to do business in Canton. Mayor Healy and the Chamber of Commerce have already scheduled a meeting with Airtran to discuss these and other issues. Mayor Healy discussed the 50<sup>th</sup> anniversary of City Hall and invited all to attend a ceremony on the plaza this Friday, October 1, 2010 at 4:30 PM. They will be opening the time capsule that was placed in the building back in 1960.
