OLD BUSINESS (PUBLIC SPEAKS): None

PUBLIC SPEAKS (CITY BUSINESS): Jen Robinson said that Chief Angelo should be at the meeting to answer questions about police brutality, and stated he's not here because he's a scapegoat for Council. She spoke about the unsanitary conditions of the jail, and that the police should not determine whether or not medical attention is needed for someone under arrest. She also believes that police brutality settlements should be taken out of police pensions. Skylark Bruce spoke about an incident where she believes a Canton resident was harassed by police for a car that had not recently been moved. She said that this is an example of enforcement of unjust laws, and that "black and brown" folks are the targets of police brutality while it is totally different in white areas. She believes that the police misconduct payments should be used for community centers, mental health services and public health. She stated that if Council does not respond to these concerns, they will elect other Council Members who will. Jasper Robinson feels that the choke hold part of the 8 Can't Wait standards should not have been modified to read "not to be used unless necessary" because the police will deem it necessary whether it is or not. He said that Council should take another look at the 8 Can't Wait from a more human aspect. Shawnalove Martin spoke about the history of Jackson Park and how nothing has been done with it since 2009, yet the City just spent \$7 million this year for an outside stage. She would rather see community centers in every part of the city. She doesn't understand why the community never gets anything they ask for because of funding, yet funds are always found for the Hall of Fame. Levi Hunter is concerned with police jobs and what they do. His house was recently shot up and his two sons were injured. They both are in the hospital, and their names were in the newspaper. He feels that is nobody's business. He stated that crime is through the roof and nobody's taking any action. There is nothing for the kids to do. He stated he was going to run for the Ward 2 Council seat next year and make changes happen. Ida Ross Freeman is not pleased with the Mayor and his Cabinet regarding the 8 Can't Wait. She said it should be 8 Can Wait because they went ahead and did things without the community being involved. She also feels the choke hold should be banned. She believes the Mayor and the Administration need to meet with and listen to the people explain what they want from 8 Can't Wait.

Update on recent violence – Police Chief Angelo**

He commended President Sherer and Council for their conduct during this meeting because he said he would have lost it. The group that was there was rude and very disrespectful. If they are going to scream and cuss, he doesn't care about their opinion. President Sherer recommended that Police Chief Angelo come to the next Council meeting on September 28th at 6:00 PM to address Member Morris's issues.
