**MISCELLANEOUS BUSINESS:** Member Smuckler thanked all the Council Members for getting through such a trying year. With the holidays upon us, he asked that everyone take a moment of silent prayer for those who are struggling due to COVID-19 and loss of jobs. Member Smith asked everyone to keep the Paul Martin family in prayer as he will be laid to rest tomorrow. He was an outstanding youth development director in Canton, he gave Member Smith her first job at City Hall, and was active with Operation Positive. She thanked everyone for all their help during the give-away this past weekend. She thanked the Lord for the wonderful weather on Friday. She also thanked Deputy Mayor Williams, Mayor Bernabei and Member Babcock for all their hard work. She also recognized Safety Director Perry and Member Hall for their help. She read a note she received from a lady who has been quarantined due to COVID-19 and could not come to the give-away. There are six kids in the home and she is asking for help. If anyone is interested in helping this family, Member Smith will provide the lady's phone number or they may call Member Smith directly. Mayor Bernabei also recognized Deputy Mayor Williams and Member Babcock for their hard work and said it's the first time he ever saw them sweating. He thanked Member Smith and stated that everything that happens at the Southeast Community Center goes through her. He said the give-away was a tremendous effort by the United Methodist Churches, and Pastor Don Ackerman from Crossroads was instrumental in bringing in many other churches that provided thousands of toys and numerous volunteers. He said that the give-away on Saturday was the biggest he's ever seen and there was a tremendous line of traffic. He recognized the athletes from McKinley High School who helped spearhead this event, Giant Eagle that contributed 1,000 turkeys and Food Soldiers that contributed 1,000 boxes of perishable food. He advised that Last Wednesday the Health Department in conjunction with the Ohio Department of Aging, Ohio Department of Health and National Guard offered drive-up COVID testing at no cost. Of 661 persons tested, 136 were positive. The Health Department will be doing this again this coming Wednesday. He thanked Health Commissioner Adams and Patty McConnell from the Health Department. The Health Department is now gearing up to administer vaccines when received. He said this is a very critical time for COVID and encouraged everyone to wear masks, social distance and consider taking the vaccine. He thanked everyone for all the good stuff accomplished this year and wished everyone a Happy Hanukkah, a Happy Kwanzaa and a Merry Christmas. Member Fisher thanked Clerk Dougherty for allowing him to appear personally tonight, and said he had to use Google maps to remember how to get here. He wished everyone a Merry Christmas, Happy Hanukkah and Happy Kwanzaa. Member Mariol thanked the Administration and his Council colleagues for their support of the Lehman Project. Member Kimbrough thanked everyone for everything, especially the Parks Department. She said the parks have never looked better and it has been uplifting to many people. The City has pulled together as a group and she believes they will have even better success next year. Kim Bell (from the audience) thanked Council, the Mayor and active members of the community. President Sherer wished happy holidays to his colleagues, everyone in attendance and the constituents. Positive things are happening in the City, and we are still dealing with COVID-19. It is a real thing, but we will get through it. He quoted his father that the secret of life is when you fall down, you pick yourself back up.
