PUBLIC SPEAKS: Kim Bell spoke again about the terrible condition of the roads in the area of 6th Street and Cherry NE and on WC Henderson Ave NE. She doesn't understand why nothing is being done to fix them. She also spoke about SMHA housing and the terrible conditions in which the residents live, and asked the City for financial help for them. James Parker spoke about parking tickets and asked Council to consider legislation to eliminate all parking meters in the downtown area. He believes this would make downtown Canton more visitor friendly. Mark Lancaster spoke about the Timken Stables where his Synagogue is currently located, and the newspaper article stating that the building is not being taken care of properly. He said that that is not accurate. They have been trying to address the violations, and he distributed copies of their rebuttal to the article to all Council Members. Heidi Lancaster, Mark's wife, stated that they are a business and a community service ministry. The building is a historical landmark, which she believes should be restored. She asked the City for funding to do so.
