**MEMBER ZACHARY:** That would be me, and, Ms. Gibbs, thank you for coming and I, this is the first I've heard of your concerns and I appreciate your coming to Council tonight. As part of the public record, if you will call me and give me the specific addresses, I will check those addresses to make sure that they have not been turned in for demolition, so to speak, and we'll get your problem resolved for you.

**MS. GIBBS:** All right, you gonna come down and check it out and see what I'm talking about?

**MEMBER ZACHARY:** I will meet with you after the meeting today. I will give you my phone number and if you would like, I can come out and meet with you.

**MS. GIBBS:** Okay. Thank you.

**PRESIDENT DENCZAK:** The next speaker is Nettie Chavers.

**MS. CHAVERS:** My name is Nettie Chavers and I reside at 1521 Rowland NE and I'm here representing, Not In Our Neighborhood Committee and we first of all, wanted to come out and say thank you, to the City of Canton for hearing our concerns and we appreciate the Gang Force and what they're doing in our community and, just to, just to let you know that we are not working against the city, we're not working against the Police Department or City Council and that we are here to work with our city and we're just, we're happy that you heard us and that things are being done and that things are moving. With the Not In Our Neighborhood Committee, it kinda crosses Ward 2 and Ward 9 but, this is a quiet to our city. So, what I came here to do also is to invite all Council members and anyone else in the city, out to the march on this Saturday, where we'll be marching. It's a Peace March and so we're just asking people to come out and support us; to let you know that, you know, that we're not just taking anything anymore, any crimes or anything like that and that we are supporting our Police Officers and we are supporting our Council and that we are also supporting the Gang Force. So we're asking that if anyone could just come out and support us this Saturday at 12 noon at, I do have a flier here that I wanted to leave, we'll be meetin' at the Canton Calvary Mission's Church on Gibbs, and like I said, this is just not for Ward 2 and Ward 9, this is for the whole City of Canton, cuz we don't just want to move the crime out of our Ward and then it goes into another Ward, we want
