MEMBER DOUGHERTY: Mr. President, yes, I'd like the Mayor...we had a conversation this morning, I read the articles about our President's statue out in California, having some difficulty with that. And she was kind enough to call out there and try to find out that, if they don't want that statue, then we sure would. And I'd like her to let everybody know what she found out.

MAYOR CREIGHTON: Mr. President, I did call Dan Hauser, who is the City Manager in Arcata, California. He recited to me that, in his eyes, it is a valued piece of their community; that they have no intention, he has no intention of letting that statue go. Although he did remind me that evidently he's up for re-election next year and that he will keep it in the file that if in case he is no longer there after November of '06, that he would ask...and he said that they have some residents that may really petition and try to get something on the ballot to have that William McKinley statue removed. And he said, so if they do, you know, I hope that you guys get it and take care of it. But he was really offended that people in that community did not want the statue of William McKinley. On another note, if I may, Mr. President, just to remind everybody that Thursday night Light Up Downtown Canton. It will be bigger and better than last year. The festivities start at about 5:30. We will have winter fireworks. I can tell you that if the clock's right, they should go off at 6:08.

PRESIDENT DENCZAK: Any other miscellaneous business?

MEMBER ZACHARY: Mr. President, I would just like to remind Council as well as audience members that this Thursday in the morning at 11 a.m. is the National Transit Tribute to Rosa Parks Day. We will be unveiling a bus with her likeness on it and dedicating that bus which will be on various routes throughout the County. So I'm encouraging everyone who can to participate.

PRESIDENT DENCZAK: Any other miscellaneous business?

MEMBER CASAR: Mr. President, I move we adjourn; seconded.
